CALL FOR PAPERS

FIRST CONFERENCE ON FINANCIAL STABILITY AND SUSTAINABILITY

The School of Economics and Finance of Universidad del Pacífico (Peru), the Center for Empirical Research in Business (CIEN) of the School of Business and Economics of Universidad Diego Portales (Chile) and the Inter-American Development Bank (IDB), invite scholars to present and discuss their work with peers at the **FIRST CONFERENCE ON FINANCIAL STABILITY AND SUSTAINABILITY**, to be held on the 20th and 21st of January 2020 at Universidad del Pacífico in Lima, Peru.

The conference will bring together policymakers, market participants and researchers. It will provide a unique opportunity for academics working in theoretical and applied topics including financial stability, financial development and financial sustainability, to present high quality research and to build connections and future collaborations among experts working in banking and finance. For policymakers and others, it will provide a forum to be informed about the latest research in these areas, including policy relevant results and evaluations.

Papers presented at the conference will undergo a standard peer review process and, if accepted, will be included in a special issue of the *Journal of Financial Stability*.

CONFERENCE FORMAT

The conference will include two types of sessions:

- Academic Sessions that follow the format of an academic workshop to discuss 30 accepted papers.
- Policy Discussions that will include keynote addresses and panel discussions in which participants from industry, regulatory agencies, and academia can share their insights.
